General Information

The Biddeford-Saco-Old Orchard Beach Transit Committee (BSOOB Transit) is requesting quotes from qualified contractors for asphalt paving services at its facility. This RFQ outlines the mandatory and optional paving scopes. The project is financed in part through grants from the Federal Transit Administration, and any contract entered into is subject to applicable laws governing those grants. All resulting contracts will be subject to applicable federal, state, and local laws and regulations. Disadvantaged Business Enterprises are encouraged to respond to this solicitation.



The paving project includes three distinct areas. Option 1 is mandatory. Options 2A/2B and 3 are optional and will be considered based on pricing.







Quote Submission Requirements

Quotes must include:

- 1. Detailed pricing for each option (Option 1 required; Options 2 and 3 itemized separately).
- 2. Timeline for completion, confirming all work will be completed by November 30, 2025.
- 3. Materials specifications and confirmation of compliance with base and overlay requirements.
- 4. Company qualifications, including relevant experience and references.
- 5. Warranty information for workmanship and materials.

Evaluation Process

Quotes submitted will be evaluated solely based on price. BSOOB Transit will select the contractor offering the lowest total cost for the mandatory scope and any optional scopes deemed feasible within budget.

Submission Instructions

Quotes are due by 1:00 pm on 11/8/2025 and may be hand delivered or mailed to BSOOB Transit Office, 13 Pomerleau St., Biddeford, Maine 04005 as well as sent electronically to Rod Carpenter at rcarpenter@bsoobtransit.org with either a request to confirm receipt via email or a "read receipt" attached to the email submission. Quotes will NOT be accepted via fax.

Davis Bacon & Certified Payroll Requirements

Contractors working on federally funded construction projects, including those receiving FTA funding, must comply with Davis-Bacon Act requirements. This begins with paying laborers and mechanics at least the prevailing wage, which includes both the basic hourly rate and fringe benefits as determined by the U.S. Department of Labor. These wages apply to all work performed on the project site, and apprentices may be paid less only if they are enrolled in a recognized apprenticeship program. Contractors are also required to submit weekly certified payroll reports using Form WH-347, even during weeks when no work is performed. These reports must detail employee information, job classifications, hours worked, wages, deductions, fringe benefits, and include a signed statement of compliance. The prime contractor bears responsibility for ensuring all subcontractors adhere to these requirements, and any non-compliance can result in penalties. Additionally, contractors must visibly post the Davis-Bacon wage determination and WH-1321 poster at the job site.

Equal Opportunity

BSOOB Transit is an equal opportunity employer and shall not discriminate against an applicant as to race, creed, age, sex, sexual preference, disability, national origin, religion, veteran status, political affiliation or any other basis prohibited by law. Vendors and contractors or their agents doing business with BSOOB shall not violate the above clause or the Civil Rights Act of 1964. Violations by vendors shall be reviewed on a case-by-case basis and may mean an automatic breach of contract. See Appendix B.

BSOOB has adopted a Minority Business Enterprise DBE/WBE Program. This program establishes a goal for DBE/WBE participation in BSOOB's total procurements.

Federal Transit Administration Clauses

Federal Transit Administration Clauses relevant to the procurement of services, materials and supplies are hereby incorporated into this specification by reference.

Proposers are required to submit written or printed quotes, signed by a person empowered to make all authorized decisions on behalf of the proposer. A signed quote is a legal agreement to abide by all listed and applicable Federal clauses. Please submit the signed and authorized agreement in Appendix A with your quote.

Agency Contact

The purchasing agent at BSOOB Transit will be the contract administrator until the time of award. Changes or additions made by anyone other than the purchasing agent will not be accepted or paid for by BSOOB Transit.

Appendix B - CIVIL RIGHTS REQUIREMENTS

The following requirements apply to the underlying contract:

- 1. **Nondiscrimination** In accordance with Title VI of the Civil Rights Act, as amended, 42 U.S.C. § 2000d, section 303 of the Age Discrimination Act of 1975, as amended, 42 U.S.C. § 6102, section 202 of the Americans with Disabilities Act of 1990, 42 U.S.C. § 12132, and Federal transit law at 49 U.S.C. § 5332, the Contractor agrees that it will not discriminate against any employee or applicant for employment because of race, color, creed, national origin, sex, age, or disability. In addition, the Contractor agrees to comply with applicable Federal implementing regulations and other implementing requirements FTA may issue.
- 2. **Equal Employment Opportunity** The following equal employment opportunity requirements apply to the underlying contract:
 - a. Race, Color, Creed, National Origin, Sex In accordance with Title VII of the Civil Rights Act, as amended, 42 U.S.C. § 2000e, and Federal transit laws at 49 U.S.C. § 5332, the Contractor agrees to comply with all applicable equal employment opportunity requirements of U.S. Department of Labor (U.S. DOL) regulations, "Office of Federal Contract Compliance Programs, Equal Employment Opportunity, Department of Labor," 41 C.F.R. Parts 60 et seq., (which implement Executive Order No. 11246, "Equal Employment Opportunity," as amended by Executive Order No. 11375, "Amending Executive Order 11246 Relating to Equal Employment Opportunity," 42 U.S.C. § 2000e note), and with any applicable Federal statutes, executive orders, regulations, and Federal policies that may in the future affect construction activities undertaken in the course of the Project. The Contractor agrees to take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, creed, national origin, sex, or age. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. In addition, the Contractor agrees to comply with any implementing requirements FTA may issue.
 - b. <u>Age</u> In accordance with section 4 of the Age Discrimination in Employment Act of 1967, as amended, 29 U.S.C. §§ 623 and Federal transit law at 49 U.S.C. § 5332, the Contractor agrees to refrain from discrimination against present and prospective employees for reason of age. In addition, the Contractor agrees to comply with any implementing requirements FTA may issue.
 - c. <u>Disabilities</u> In accordance with section 102 of the Americans with Disabilities Act, as amended, 42 U.S.C. § 12112, the Contractor agrees that it will comply with the requirements of U.S. Equal Employment Opportunity Commission, "Regulations to Implement the Equal Employment Provisions of the Americans with Disabilities Act," 29 C.F.R. Part 1630, pertaining to employment of persons with disabilities. In addition, the Contractor agrees to comply with any implementing requirements FTA may issue.

Appendix C - Disputes and Protests

Disputes

Biddeford Saco Old Orchard Beach Transit Committee will work with firms and vendors to resolve disputes arising from its procurement of goods and services. If such disputes cannot be resolved through negotiation between the vendor and the Executive Director, The Transit Committee may render a decision on the matter.

Nothing in this policy mitigates the right of the vendor to seek legal remedy in a court of competent jurisdiction.

Biddeford Saco Old Orchard Beach Transit Committee may seek the assistance of the grantor agency in resolving disputes.

Protests After Bid Opening/Receipt of Proposals

Any party aggrieved by an award of a contract may protest to Biddeford Saco Old Orchard Beach Transit Committee, in writing, within 7 days after such aggrieved party knew or should have known of the facts giving rise thereto. Such protest shall include the detailed facts leading up to the protest. The Chairperson of the Biddeford Saco Old Orchard Beach Transit Committee is authorized to settle and resolve any protest relating to the solicitation or contract award. Protests received later than 30 days after bid opening or the receipt of proposals shall not be considered.

In the absence of a settlement, the Chairperson shall make his or her decision known, in writing, within one week of receipt of the protest. Such decision shall respond, in detail, to each substantive issue raised in the protest.

The written decision of the Chairperson shall be final, binding, and conclusive on the parties.

Protests will only be entertained by the Federal Transit Administration if the aggrieved party is alleging that Biddeford, Saco, Old Orchard Beach Transit Committee does not have, or is failing to follow, written protest procedures. The protester must deliver its appeal to the FTA Regional Administrator for the region administering its project or the FTA Associate Administrator for the region administering its project or the FTA Associate Administrator for the program office administering its project within 5 working days of the date when the protester has identified other grounds for appeal to FTA.
